3	Brief details of dispute/litigation:	NuFuture has filed an interlocutory application before the National Company Law Tribunal alleging that an amount of Rs.50 Lakh was repaid by NuFuture to the Company towards an antecedent unsecured loan during the period of financial distress within the statutory look-back period and therefore, the repayment constitutes a preferential transaction under Section 43(2) of the Insolvency and Bankruptcy Code, 2016. The Resolution Professional has sought reversal of the alleged preferential repayment of Rs.50 lakh and such other order as the Tribunal may deem fit and proper.
4	Expected financial implications, if any, due to compensation, penalty etc.	The Company is in the process of seeking legal advice for determination of the same and at present the Company is unable to quantify or determine the financial implications.
5	Quantum of claims, if any.	Rs. 50 Lakh as sought in the interlocutory application.
